This program is designed to make it easy for integrators and consumers to know with confidence which third-party products “play well” with the Control4 automation system. Such products may be labeled with our new **Connects with Control4** or **Connects with Control4 Certified** badges to provide at-a-glance identification of third-party products that interoperate with Control4.

Usage by Manufacturing Partners and Driver Developers

We stand behind our commitment to interoperability—our open platform gives manufacturers and driver developers several ways to integrate with Control4. Manufacturers and driver developers can utilize the **Connects with Control4** badge to promote their integration to Control4 authorized dealers and consumers. This badge can be used on product packaging, documentation, marketing materials, and websites.

Integrations eligible for the **Connects with Control4** program may include drivers that control products via IP, IR, serial, ZigBee and ZWave. Integrations that leverage the Control4 REST API are also eligible. All manufacturers and driver developers that wish to use the **Connects with Control4** branding must adhere to the guidelines on pages three and four of this document.

CONNECTS WITH CONTROL4 QR CODE

The latest version of Composer Express now includes the ability to scan a **Connects with Control4** QR code and automatically add the correct driver to a Control4 project. This capability will simplify the installation and ensure the dealer is using the right driver every time. **Connects with Control4** QR codes are intended for products that cannot be discovered through Simple Device Discover Protocol (SDDP) or through ZigBee. Applicable devices include those controlled through IR, serial and ZWave.

Manufacturers may include the **Connects with Control4** QR code on their product, packaging, in the documentation, on marketing materials, or on their website. Guidelines for generating the QR code can be found [here](#).



CONNECTS WITH CONTROL4 CERTIFIED

Manufacturer partners may elect to have their drivers or integrations certified by Control4. This certification provides dealers and consumers with confidence that the integration with Control4 is complete and reliable.

Control4 Certification improves the quality of integrated solutions, which leads to happier customers and improved market share for our ecosystem partners. Once the rigorous testing and certification process is complete, these products are deemed “Control4 Certified” and a **Connects with Control4 Certified** badge may be used by the manufacturer for marketing purposes. Only products that have been through this certification process are eligible to use the **Connects with Control4 Certified** badge.

The new **Connects with Control4** makes it easier than ever for Control4 custom integrators to select products for their customer installations that “play well” with Control4. Integrators can choose from an ever-expanding list of Control4 compatible products. 


