

# Grant of Rights and Talent Release Agreement

I, the undersigned, enter into this Agreement with Control4 Corporation (“Control4”). I have been informed and understand that Control4 is producing and gathering content to be used in its marketing and promotional materials (the “Content”) and I desire that my name, likeness, image, voice, appearance and/or performance, or images of my property be recorded by Control4, so that and these recordings, along with any other photographs, digital and/or electronic files, or other information that I provide to Control4, may at Control4 sole discretion be included in any such Content.

Control4 or its designee shall have complete ownership of the Content in which I appear, including copyright interests, and I hereby assign to Control4, without further compensation, all right, title and interest that I may have in the Content and acknowledge that I have no interest or ownership in the Content or its copyright.
- 2** The right to broadcast, exhibit, market, sell and otherwise distribute the Content, either in whole or in parts, and either alone or with other products, for commercial or non-commercial use or for any other purpose that Control4 or its designees in their sole discretion may determine.
- 3** I confirm that I have the right to enter into this Agreement, that I am (i) 18 years old or if not (ii) that my parent or guardian consents to this Agreement as indicated by their co-signature below, that I am not restricted by any other commitments, and that Control4 has no financial commitment or other obligations to me as a result of this Agreement. I expressly release and indemnify Control4 and its officers, employees, agents and designees from any and all claims known and unknown arising out of or in any way connected with the above granted uses and representations.

The rights and licenses granted herein are perpetual, irrevocable, royalty-free and worldwide. In consideration of all the above, I hereby acknowledge receipt of reasonable and fair consideration from Control4, including the potential use of my name, likeness, image, voice, appearance and/or performance or other materials provided in its Content.
